#### Measures taken to protect the ancient and traditional knowledge of the country

A total of 448764 ISM formulations including 127533 in Ayurveda, 240850 in Unani, 70158 in Siddha, and 5445 in Sowa Rigpa, and 4778 in Yoga techniques have been transcribed so far into the Traditional Knowledge Digital Library (TKDL) database. On the basis of TKDL evidences, so far, 283 patent applications have been either refused, amended, or withdrawn/abandoned, thus protecting Indian traditional knowledge.

# AYUSH courses through fellowship programmes offered by premier AYUSH institutions in the country

The number of foreign nationals undertaking AYUSH courses in premier AYUSH institutions in the country under AYUSH scholarship/fellowship programmes of the Ministry of AYUSH, is 247. An AYUSH Information cell is set up in foreign Countries with the mandate to disseminate authentic information about AYUSH systems of Medicine and to undertake various AYUSH Promotional activities. The Ministry of AYUSH has supported the establishment of 39 AYUSH Information Cells in 35 foreign nations. Recently, the latest AYUSH Information Cell in Japan was inaugurated on March 9, 2023. A health centre i.e. Panchakarma Centre in Havana (Cuba) has been established by the Ministry of Public Health, Cuba with the technical support of the Ministry of AYUSH in 2019. Under the Country to Country MoU signed with Cuba, the Ministry of AYUSH deputed one Ayurveda Expert and two Ayurveda therapists to Havana, Cuba, for providing their services for the Panchakarma Centre at, Havana, Cuba in November, 2019.

# Update on Mental Health services in Primary Health Centres

to States/UTs through the National Health Mission. establishment of a medical college under Public Private Partnership (PPP) model. Clause 2(5) of Establishment of Medical College Regulations, 1999, prescribes that the appropriate Government may allow the utilization of the facilities of a hospital owned and managed by it for establishing a Medical College by a person/agency /trust/society /company by entering into a Memorandum of Understanding for this purpose. Such hospitals should have minimum 300 beds with necessary infrastructural facilities capable of developing into teaching institution for the proposed medical college.

Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) is implemented in 33 States/UTs. The scheme is implemented in convergence with over 20 State specific schemes. Cobranded Ayushman Card is issued to the eligible beneficiaries supported by Centre and State in all the 33 States/UTs. As of March 9, 2023, a total of 23.19 crore Ayushman cards have been created against the verified beneficiaries and over 4.44 crore hospital admissions worth Rs. 53,350.20 crores have been authorized through a network of 25,969 empaneled healthcare providers including 11,700 private hospitals.
