## **Initiatives To Curb Rising Mental Health Cases In India**

For providing affordable and accessible mental healthcare facilities to the population, including the poor and underprivileged, the Government is implementing National Mental Health Programme (NMHP) in the country. The District Mental Health Programme (DMHP) component of the NMHP has been sanctioned for implementation in 704 districts for which support is provided to States/UTs through the National Health Mission. Facilities made available under DMHP at the Community Health Centre (CHC) and Primary Health Centre (PHC) levels include outpatient services, assessment, counseling/ psychosocial interventions, continuing care and support to persons with severe mental disorders, drugs, outreach services, ambulance services, etc. In addition to the above services, there is a provision of 10 bedded in-patient facility at the District level.

In this regard, National Cancer Institute at Jhajjar (Haryana) and Chittaranjan National Cancer Institute, Kolkata (First and Second Campus) have been set up by the Ministry of Health & Family Welfare.

## **Government has taken various regulatory measures since 2019 to ensure the quality of medicinal products in the country**

The Government has taken various regulatory measures since 2019 to ensure the quality of medicines in the country. The key measures are as under:

- a. The Drugs Rules, 1945 were amended providing that every Active Pharmaceutical Ingredient (bulk drug) manufactured or imported in India shall bear Quick Response Code on its label. The stored data or information shall include the minimum particulars including Unique product identification code, Batch No, Manufacturing date, and Expiry Date.
- b. The Drugs Rules, 1945 were amended providing that any marketer who sells or distributes any drug shall be responsible for the quality of that drug as well as other regulatory compliances along with the manufacturer under these rules.
- c. The Drugs Rules, 1945 were amended providing that "in case the applicant intends to market the drug under a brand name or trade name, the applicant shall furnish an undertaking in Form 51 to the Licensing Authority to the effect that to the best of his knowledge based on search in trademarks registry, central database for brand name or trade name of drugs maintained by Central Drugs Standard Control Organisation, literature and reference books on details of drug formulations in India, and internet, such or similar brand name or trade name is not already in existence with respect to any drug in the country and the proposed brand name or trade name shall not lead to any confusion or deception in the market".
- d. The manufacture for sale and distribution of 80 Fixed Dose Combinations (FDCs) drugs in India was prohibited in public interest after consultation with the Drugs Technical Advisory Board.
- e. 220 additional posts of various levels have been created including Joint Drugs Controller, Deputy Drugs Controller, Asst. Drugs Controller and Drugs Inspector in the year 2022-23. In a historic achievement, India's cumulative COVID-19 vaccination drive has surpassed the 200-Crore milestone.

## **NATIONAL TUBERCULOSIS CONTROL PROGRAMME**

The Government has implemented the National TB Elimination Programme (NTEP) under the aegis of the National Health Mission (NHM). With the goal of achieving Sustainable Development

Goals related to TB by 2025, five years ahead of the global targets, the programme has implemented a National Strategic Plan with the following objectives: -

- a. Early diagnosis of TB patients, prompt treatment with quality assured drugs and treatment regimens.
- b. To engage with the patients seeking care in the private sector.
- c. Prevention strategies including active case finding and contact tracing in high-risk/vulnerable population.
- d. Airborne infection control.
- e. Multi-sectoral response for addressing social determinants.

#### **4.14 crore Adolescents provided Weekly Iron Folic Acid Supplementation under the Weekly Iron and Folic Acid Supplementation (WIFS) Programme in 2021-22**

The government of India has been working for ensuring women and child health. Progress made in the various interventions under Rashtriya Kishor Swasthya Karyakram is as below:

- a. Total 7203 Adolescent Friendly Health Clinics (AFHCs) have been established in the country; 52 lakh Adolescent clients received counseling and clinical services in AFHCs during 2021-22
- b. 4.14 crore Adolescents were provided Weekly Iron Folic Acid Supplementation tablets under the Weekly Iron and Folic Acid Supplementation (WIFS) Programme in 2021-22
- c. The Scheme for Promotion of Menstrual Hygiene is implemented to promote menstrual hygiene among adolescent girls in the age group of 10-19 years. 34.92 lakh adolescent girls have been covered every month under this scheme in FY 2021-22 both through the Centre and State budgets.
- d. 7.64 lakh Peer Educators (PEs) have been selected during the period of 2016-17 to 2020-21 and out of these, 5.46 lakh Peer Educators have been trained. A total of 1.46 Lakh Adolescent Health and Wellness Days (AHWDs) were held in FY 2021-22 for awareness creation in communities and stakeholders.

The subject of artificial organs is not regulated under the aforesaid Act.

National Health Mission (NHM) envisages the achievement of universal access to equitable, affordable & quality health care services that are accountable and responsive to people's needs. NHM encompasses its two Sub-Missions, the National Rural Health Mission (NRHM) and the National Urban Health Mission (NUHM). The main programmatic components include Health System Strengthening in rural and urban areas, Reproductive-Maternal- Neonatal-Child and Adolescent Health (RMNCH+A), and Communicable and Non-Communicable Diseases.

## Research and Development for traditional system of medicines

The Government of India has signed 25 Memorandum of Understandings (MoUs) for country-to-country cooperation in the field of medicine with Nepal, Bangladesh, Hungary, Trinidad & Tobago, Malaysia, Mauritius, Mongolia, Turkmenistan, Myanmar, World Health Organization, Germany, Iran, Sao Tome & Principe, Equatorial Guinea, Cuba, Colombia, Japan, Bolivia, Gambia, Republic of Guinea, China, St Vincent & the Grenadines, Suriname, Brazil, and Zimbabwe. 37 MoUs for undertaking collaborative research and development of Traditional Medicine have been signed with foreign Institutes/Universities/Organizations from the USA, Germany, UK, Canada, Malaysia, Brazil, Australia, Austria, Tajikistan, Saudi Arabia, Ecuador, Japan, Indonesia, Reunion Island, Korea, Hungary, etc. 15 MoUs have been signed for setting up of Ayush Academic Chairs in foreign Institutes/Universities from Hungary, Latvia, Mauritius, Bangladesh, Russia, West-Indies, Thailand, Indonesia, Slovenia, Armenia, Argentina, Malaysia, South Africa, Australia, and Mexico.

### Ayush Mark Certification Scheme

Ayush Mark Certification Scheme is operated by the Quality Council of India (QCI) since 2009. The salient features of the scheme are as follows:

- a. It is a voluntary certification scheme for ASU&H products having two levels: Ayush Standard Mark and Ayush Premium Mark.
- b. The Ayush Standard Mark is based on Good Manufacturing Practices (GMP) for Ayurvedic, Siddha, and Unani medicines (Schedule T) as per Drugs and Cosmetic Rules, 1945. AYUSH Premium Mark is based on WHO's GMP guidelines covering herbal medicines.
- c. For any manufacturer to qualify for AYUSH Mark Certification, compliance with the domestic regulations is a pre-requisite. The products are certified post regulatory approval given by the State Licensing Authority of the state government concerned.

### **Steps taken to promote traditional medical tourism**

During the inaugural ceremony of the “Global Ayush Investment and Innovation Summit” held on 20th April 2022 at Gandhinagar, Gujarat, Prime Minister made the announcement to launch a special category of Ayush visa for tourists visiting India for Ayush medical tourism/education/treatment including Yoga. Accordingly, the Ministry of Ayush has requested the Ministry of Home Affairs to work out the modalities for the creation of a separate category for Ayush Visa/eVisa. It is a part of Heal in India campaign to promote traditional medical tourism.

### **Steps taken to Improve Coverage under AB-PMJAY Scheme**

Ayushman Bharat–Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) is an entitlement-based scheme. Eligible beneficiaries can directly visit any empanelled public or private hospital to avail cashless treatment. Ayushman cards are issued to the beneficiaries to create awareness about the scheme. National Health Authority in association with State Health Agencies has fast-tracked the process of issuance of cards to the beneficiaries across the country.

Setting up of 22 new AIIMS has been approved under Pradhan Mantri Swasthya Suraksha Yojana (PMSSY), 6 of which at Bhopal (Madhya Pradesh), Bhubaneswar (Odisha), Jodhpur (Rajasthan), Patna (Bihar), Raipur (Chhattisgarh), and Rishikesh (Uttarakhand) are fully functional. ### **Update on National Program for Healthcare of the Elderly**

The Ministry of Health & Family Welfare launched the “National Programme for the Health Care of Elderly” (NPHCE) during 2010-11 to address various health-related problems of elderly people. The objective of the Programme is to provide accessible, affordable, and high-quality long-term, comprehensive and dedicated care services to an Ageing population. The Programme is implemented as Centrally Sponsored Programme at two levels:

- a. Primary care services at district hospitals and sub-district level through geriatric clinics, investigations & rehabilitation services, domiciliary visits by the rehabilitation worker for bed-ridden elderly, and counseling to family members for care of such patients and Health Education. A total number of 713 Districts have been covered.
- b. Tertiary care services through OPD and in-door facilities, development of specialized human resource through various courses in geriatric medicine as well as research at Regional Geriatric Centers and National Centres for Ageing. Under this Component, Two National Centres of Ageing (NCAs) and 18 Regional Geriatric Centres (RGCs) have been set up.

## Update on NFHS-5 & Rural Health Statistics

The Ministry of Health and Family Welfare has released the National Report of the fifth round of the National Family Health Survey (NFHS), which is available in the public domain (<http://rchiips.org/nfhs/>). The major findings evident from NFHS-5 (2019-21) as compared to NFHS-4 (2015-16) are given in Annexure I. The information on various important indicators captured in NFHS-5 is used for monitoring the SDG-related health goals. India has made significant progress in various SDG health indicators like Total Fertility Rate (TFR), the proportion of pregnant women who had an ANC visit in the first trimester, Institutional Births, Child immunization, etc. A list of SDG indicators, where NFHS-5 is the data source is given in Annexure II.
